

PRIZE COMPETITION RULES

15th FESTIVAL OF LOŠINJ CUISINE

Article 1: ORGANISER

Prize Competition brought and organised by: Tourist Board of the Town of Mali Lošinj, Mali Lošinj, Priko 42, Republic of Croatia. PIN: 05241851972 (hereinafter: the Organiser).

Article 2: DURATION, PURPOSE AND LOCATIONS OF THE PRIZE COMPETITION

Prize Competition of the 15th Festival of Lošinj cuisine (hereinafter: the Competition) is carried out for the purpose of promoting the Organiser on its official Facebook page Lošinj - Island of vitality (<https://web.facebook.com/visitlosinj>), as well as on the Instagram page [VisitLosinj](#)

The Prize Competition lasts from 27 April 2023 at 2 p.m. until 31 May 2023 at 11.59 p.m.

The person applying to participate in the Competition is hereinafter referred to as the Participant. The Competition is in no way affiliated with, sponsored or promoted by any social media platform referred to in these rules.

Article 3: AREA OF PROMOTION

All information on the Competition shall be available on the official visitlosinj.hr website and the Lošinj – Island of vitality Facebook page.

Article 4: RIGHT TO PARTICIPATION

All individuals over the age of 18 as at the date of the start of this Competition have the right to participate in this Competition, except for employees of the Organiser, as well as members of their immediate family (parents, spouses, children, sisters and brothers) – nor any other person who participated in the preparation of this Competition.

Article 5: HOW TO PARTICIPATE IN THE PRIZE COMPETITION

The goal of the Competition is for the Participant to share a photo/post related to the 15th Festival of Lošinj Cuisine on their social media; their Facebook and/or Instagram page; specifically, the specialties/menus they tried with an obligatory use of the hashtag #LosinjFoodFestival (several posts/pieces of content may be published, i.e. several specialties).

The Organiser shall have no access to user data apart from the data that is publicly available on social media. Any use of fake or duplicate profiles or reasonable doubt of their existence shall be sanctioned with the elimination of the Participant from the Competition. The Organiser cannot know which personal data shall be transferred via social networks, nor in what way and to what extent such data shall be used by social networks or third parties. It is recommended for the Participant to get familiar with the data protection rules on the aforementioned social networks.

Article 6: WINNER SELECTION

The winner shall be the person who posts the most creative menu photos or posts the most photos of diverse menus. According to the selection of the expert jury, the winner is the one who offers the most creative solutions to the given task.

The names of prize winners shall be published in accordance with the provisions of Article 15 of these Rules.

Article 7: PRIZES DETERMINED BY THE ORGANISER

The prizes consist of:

- 1 Dolphin Watching Tour (x2)
- 2 Theme observatory Providenca (x)
- 3 The Museum of Apoxyomenos and the Osor time machine (x2)
- 4 Romantic dinner (x2)
- 5 Wellness treatment (x2)

One participant can only win one prize.

Article 8: HOW TO CLAIM THE PRIZE

After the Competition is closed, 5 winners shall be informed on the prize won via the Lošinj - Island of vitality Facebook page.

The prize cannot be exchanged for money or transferred to another person. The prize delivery deadline is 7 days following the day the winner is announced.

Article 9: PRIZE COMPETITION PARTICIPANTS

Participants in the prize competition cannot claim prizes in larger quantities or other prizes than those specified in these Rules by the Organiser. By participating in this prize competition, the participants accept these Rules.

The Organiser shall review all received responses and reserves the right to disqualify registered Participants at any time if:

- the participant violates the Rules;
- the participant does not respond to the Organiser's inquiry within 24 hours or enters incorrect personal data or cannot be contacted for some other reason;
- they do not adhere to the theme of the Competition;
- the content submitted is offensive or vulgar, it mentions public figures or the text represents content that is not in accordance with the law

Article 10: MISTAKES AND INCORRECT APPLICATIONS

Incorrect or incomplete applications are invalid and do not have the right to claim any prize. Multiple Participants with the same posts or home address shall be considered a single winner. If the Competition Participant enters any inappropriate or offensive content, they shall be removed and shall not be regarded as a regular Competition application.

Article 11: PUBLICITY

By participating in the prize competition, the Participants agree that their contribution to the Facebook competition can be published and used by the Organiser free of charge in print, audio, image and video material for marketing purposes only, irrevocably in temporal and territorial terms in all media and on all social networks.

This Competition is in no way affiliated with Facebook, Facebook does not promote or sponsor it. Data is provided exclusively for the purposes of the complete functionality of this competition to the Tourist Board of the Town of Mali Lošinj and not to Facebook. Facebook is a public space and the publication of any content (including photos) may constitute an invasion of privacy, both of the Participants of the competition and of third parties. If the Competition Participants publish any content below the Facebook post with the prize competition, it shall be considered that they published it voluntarily and Facebook is not responsible for the content thereof, nor for the misuse of such content by any third parties. Also, if the Participants post any content under the Facebook post with the prize competition (including photos, text messages, comments, any personal information, etc.) it shall be considered that they have all the necessary authorisations to post such content. With such a publication, the participants of the competition give the company Tourist Board of the City of Mali Lošinj permission to use the entire published content for marketing and any other commercial purposes, and at the same time renounce all material and any other rights that belong to them on this basis.

Article 12: TYPES AND USE OF COLLECTED INFORMATION / DATA

By participating in this Competition, the Participants agree that the Organiser collects, processes and publishes their personal data as well as the personal data of the person to whom the prize shall be sent, which the participants themselves provided in this Competition (such as name, address, e-mail address, city and phone number) and is used for marketing and promotional purposes related to this Prize Competition

and in an exclusive and territorially unlimited manner, in all media. The Organiser shall keep all personal data collected in connection with this Competition for one year from the date the competition is closed, unless the Participant requests the deletion of their data.

The Participant is free at any time to withhold their consent regarding the collection and processing of personal data and accepts that such denial may result in the failure to participate in the Competition.

The organiser shall use the personal data specified in paragraph 1 of this Article for:

- 1 Contacting the Participant to arrange the delivery of the prize
- 2 Delivery of the prize to the Participant
- 3 Publishing the names of the winners on TZGML social media

Article 13: RIGHTS OF PARTICIPANTS IN RELATION TO PERSONAL DATA

By sending an e-mail to losinj@visitlosinj.hr, the Competition Participants have the right to:

- 1 Request access to the personal data stored by the Organiser
- 2 Request access to information on what the personal data prepared by the Organiser is used for
- 3 Request the correction or addition of personal data stored by the Organiser
- 4 Request the deletion of personal data stored by the Organiser
- 5 Request to stop the processing of personal data if there is a reasonable doubt that their data is not being processed in the defined way
- 6 File an objection to the data collected and processed by the Organiser

Article 14: PUBLISHING PERSONAL INFORMATION/DATA

The Organiser shall not share personally identifiable information with other parties, but may share information about Participants with related companies.

The Organiser provides certain services via third parties. The third party carries out certain activities on behalf of the Organiser and for its account, such as organising the delivery of the Prize.

The Organiser is authorised to disclose the Participant's personal identification information/data when it is reasonable to expect that their disclosure shall assist in law enforcement or is necessary as a result of a court order.

Article 15: ANNOUNCING THE WINNERS

The winners shall be announced in the comment below the post with the task on the official Facebook page Lošinj - Island of Vitality of the Tourist Board of the City of Mali Lošinj and on the IG Story of the VisitLosinj page. After the Competition is closed, all 5 winners shall be announced.

Article 16: TAXES

The winner is not obligated to pay any taxes, duties or fees directly related to the prizes.

Article 17: IN CASE OF DISPUTE

In the case of a dispute between the Organiser and the Participants of the prize competition, the Municipal Court in Rijeka has jurisdiction.

Article 18: POSSIBILITY OF TERMINATION OF THE PRIZE COMPETITION

The Organiser reserves the right to terminate the Competition, in the event of circumstances for which the Organiser is not responsible, i.e. which it could not prevent, remove or avoid, in which case it is discharged from all possible obligations towards the Participant. The Organiser is not liable for technical problems or errors in data entry and other reasons beyond the control of the Organiser. The participant who takes part in the Competition accepts the rights and obligations from the Rules. The Organiser reserves to right to change the Rules, about which all Participants shall be notified in due time on the Town of Mali Lošinj Tourist Board Facebook page <https://web.facebook.com/visitlosinj>.
