



## TZ2 FORM

**Persons who provide hospitality services in their household or on a family farm** must submit the TZ2 Form to the competent Tax Administration office by 15 January 2025 for the period covering the year 2024. The TZ2 Form is submitted according to the place of permanent residence or temporary residence (in person, by mail or e-mail)

**Non-resident renters** submit the TZ2 Form to the Tax Administration's Local Office for Non-Residents at following address:

Under item 17 of the TZ2 Form, you should enter the total amount of receipts from the 2024 turnover records.

## VAT ON FOREIGN INTERMEDIARIES' COMMISSION

**In case they are cooperating with online accommodation advertisers based in other EU Member States**, such as Booking or Airbnb, renters are required to have a valid VAT identification number and to report, calculate and pay VAT at a rate of 25% on the commission for services received.
